WHEREAS, the negotiating teams for the Hampton Bays Union Free School District (“District”) and the Hampton Bays Teachers’ Association (“HBTA”) executed a Memorandum of Agreement dated July 15, 2011, calling for the creation of a three-year successor Collectively Negotiated Agreement to the one that expired on June 30, 2011; and

WHEREAS, the Board is required by law to approve the expenditure of additional monies required to fund the provisions of the Collectively Negotiated Agreement;
